Parade Application and Waiver Form (on back) must be completed and mailed to the address shown below by November 20, 2009. Limited to the first 100 entries.

Entry fee of \$35.00 must accompany application. Make check payable to: Kinston Christmas Parade.  
**Late fee charge of additional \$25.00 if not received by November 20, 2009.**

All floats must have **Christmas** theme.

For each float we encourage appropriate Christmas music.

Float must have a sign or banner to identify your group or business.

No distribution of candy or other items is allowed.

Tractors and pick-up trucks can be used to pull floats but cannot be floats.

Please no Santa on your float... there will be one at the end of the parade and we do not want to confuse children.

Judging of floats will be at the staging area and winners will be announced during the parade. Trophies will be awarded for the following categories *(Rental or Professional Floats are not eligible for judging and awards.)*
