GUIDELINES:

Parade Application and Waiver Form (on back) must be completed and mailed to the address shown below by November 20, 2008. Limited to the first 100 entries.

Entry fee of \$35.00 must accompany application. Make check payable to: Kinston Christmas Parade.
Late fee charge of additional \$25.00 if not received by Friday, November 20, 2009.

All Pageant Winners under the age of twelve (12) must be accompanied by a parent, guardian or responsible adult in addition to the driver.

All Pageant Winners under the age of six (6) must sit in the car and may not sit on the hood, trunk or sunroof of the vehicle.

No distribution of candy or other items is allowed.

Please no Santa...there will be one at the end of the parade and we do not want to confuse children.

Signs identifying the name of the pageant and the winner must be displayed on the right and left sides of the vehicle. (professionally designed magnetic signs are recommended.)

ROUTE:

Participants will line up at staging area between 8:45 – 9:30 AM on December 13, 2008 (maps and directions will be mailed to you upon application approval).

Parade route is south on Queen Street; turn left on Caswell Street with disbursement at corner of Caswell & Bright Street.

All entries must stay within middle two lanes throughout the entire route. **This rule is strictly enforced.**

The Parade Committee reserves the right to deny entrance to parade for:

late arrivals

entries that do not comply with guidelines

entries deemed inappropriate or unsafe
